

Privacy Policy

DanielePiroddi.com is committed to safeguarding the privacy of personal data and complying with the UK Data Protection Act 1998 and any future changes in data protection legislation that we are required to comply with.

This policy sets out how we will make use of any personal data we collect from you as a visitor to our website, as a member or a licensee, or that we collect from third party sources. It also describes your data protection rights, including a right to object to some of the processing which we carry out. More information about your rights, and how to exercise them, is set out in the 'Your rights' section.

Data Controller

A Data Controller is a person or organisation who decides why and how information about you (personal data) will be stored, shared and used. For data collected, stored and processed by www.danielepiroddi.com is the Data Controller.

What data we collect

The personal data we collect from you includes:

- questions, queries or feedback you leave, including your email address if you contact us via www.danielepiroddi.com
- your email address and subscription preferences when you sign up to our email alerts
- how you use our emails - for example whether you open them and which links you click on
- your Internet Protocol (IP) address, and details of which version of web browser you used
- information on how you use the site, using cookies and page tagging techniques
- We use Google Analytics software to collect information about how you use www.danielepiroddi.com

Google Analytics stores information about:

- the pages you visit on www.danielepiroddi.com
- how long you spend on each www.danielepiroddi.com page
- how you got to the site
- what you click on while you're visiting the site
- We do not collect or store your personal information through Google Analytics (for example your name or address) so this information cannot be used to identify who you are.

Why we need your data

We collect information through Google Analytics to monitor how you use the site. We do this to help:

- make sure the site is meeting the needs of its users
- make improvements, for example improving site search

We also collect data in order to:

- gather feedback to improve our services, for example our email alerts
- respond to any feedback you send us, if you've asked us to
- send email alerts to users who request them
- allow you to access our services and make transactions
- provide you with information about other services if you want it
- promote events or services
- monitor use of the site to identify security threats

The legal basis for processing all other personal data is that it's necessary to perform a task in the public interest.

What we do with your data

The data we collect may be shared with the Agent or Manager of www.danielepiroddi.com

We will not:

- sell or rent your data to third parties
- share your data with third parties for marketing purposes

We will share your data if we are required to do so by law – for example, by court order, or to prevent fraud or other crime.

How long we keep your data

We will only retain your personal data for as long as:

- it is needed for the purposes set out in this document
- the law requires us to
- We will keep your email data until you unsubscribe.
- We will keep your feedback data for 5 years.

Children's privacy protection

Our services are not designed for, or intentionally targeted at, children 13 years of age or younger. We do not intentionally collect or maintain data about anyone under the age of 13.

How we protect your data and keep it secure

We are committed to doing all that we can to keep your data secure. We have set up systems and processes to prevent unauthorised access or disclosure of your data – for example, we protect your data using varying levels of encryption.

We also make sure that any third parties that we deal with keep all personal data they process on our behalf secure.

Links to other websites

DanielePiroddi.com are not responsible for the content and practices of third party websites where we have links from our website. Links to other websites are often provided solely as reference points to information on topics that may be useful to our users.

This privacy notice will no longer apply if you use a link to go from www.danielepiroddi.com website to a third-party website. Your browsing and interaction on any other website are subject to that website's own privacy notice and we encourage you to read their own privacy statements.

Your rights

You have the right to request:

- information about how your personal data is processed
- a copy of that personal data
- that anything inaccurate in your personal data is corrected immediately

You can also:

- raise an objection about how your personal data is processed
- request that your personal data is erased if there is no longer a justification for it
- ask that the processing of your personal data is restricted in certain circumstances
